Dear Krystal,

As you can imagine, when I got the call from Jeff Chirico regarding your admissions to him regarding my case, I was excited beyond words...deeply touched as well. He said my family was the first you mentioned. I always had a thought from the beginning that you were honestly engaged in the case and understood the wrong Tusan was doing. Although I have found out this week that it was Dawn Dixon and not you that gave me all those initial hearings, I still believe that you knew then how bad my children and I were being abused by the court—you reaching out to me recently certainly confirms my belief.

During that initial conversation with Chirico, he was able to articulate to me your sense of ambivalence by coming out with the information. I found his characterization of you really odd. Here you were coming to him and outing the court but hesitant to go all the way. You were then, as you are now, very concerned about soiling your career and reputation in the community with regard to being a whistleblower. This fact was crucial in my understanding that you were an unstable witness and were not steadfastly committed to doing what was right. Don't misunderstand, I knew you had bad feelings about what Tusan and you and others did to me and my children and my ex-wife and others, but it became clear that you were only going to do what was convenient for you and if something happened to tip the scales back, you would grow cold and be a part of the cover up and not the clean up.

With this at the top of my mind, we agreed to meet and I faithfully respected your wishes for me to keep that meeting confidential. However, anticipating the instability of your commitment to follow through with helping my family, I decided to videotape and audio tape our conversation. The videotape came from my computer webcam and the audiotape came from my phone and a digital recorder taped underneath the table that sat between us. I took video for the purposes of using it in the media as it would not be admissible in Court. And of course, I took the audiotapes due to its undeniable admissibility in court.

I was very conflicted about doing this without you knowing but if you can for a second put aside your feelings of being betrayed, you will understand that both you and Tusan betrayed me and my boys and if you were to back out now, you would have betrayed us twice...and in fact, that is what you did. You backed out and therefore have attempted to betray us. I initially thought your story about somebody getting into your email was your way of you lying to get out of helping me. I still have some doubts

about the veracity of your claims that someone got into your email....it certainly was not me. To that point I felt you were in earnest and your intentions were golden. When you accused me of hacking and then went cold, I was thankful that I chose to tape you extensively. It was 2.5 hours of some really good footage but not as explosive as what you would give me later.

As you might imagine, our subsequent conversations were recorded and as you might also imagine, I am thankful that I chose to do so as your recent rejection of me and my children proved confirmation that my decision was wise. While it was clear you were censoring some of your comments to me about Tusan and your participation, you gave me a lot of good information about criminal and civil crimes and many conspiratorial aspects about the court's inner workings. With or without your partnership going forward, those tapes will be invaluable for me to get my children the help they need and to get justice for me and my ex-wife.

On Monday of last week, you sent me a rather insensitive (to put it mildly) email stating the following: *"Mr. Higdon, I don't want my address to be published, or filed on public record. Further, mere statements are insufficient. So, not sure if I would be of much help."* Imagine for a moment that you were me and received such an email...what would you be feeling? I am certain you could not have thought that through very well with my children and I in mind---when you took that stance I am certain you thought that only your unrecorded statements were at issue. I was deeply saddened that you would take such a turn. It made me think that your initial intentions were not really to help me and my children. IN fact, since that email I have come to find out that your relationship with Tusan was not so rosy. This fact you were somewhat deceptive about. You said you were in good standing and had a great reference, but I have come to find out since then you were not being truthful. Fortunately I do have confirmation that your reference was decent, but it is not true that things were great between you both. I choose, however, to continue thinking that your coming out about my family was mostly to help us, if not completely from that motivation alone.

When you texted last Tuesday *"I will touch bases with you at a later date"* I knew you had made a complete about face. That night was the first time I told anyone of our conversations. I secured a lawyer, consulted with my friends in law enforcement, and contacted the judicial corruption unit of the FBI the following morning. I then spoke with Chirico who wanted to ask you for help with the GAL's email to Tusan regarding the fees. About 30 minutes after his call to you, I got the following email from you saying *"Please do not email me or text me or call me anymore."* All I can say to you is...read that text, think about me and my children receiving it from someone involved in the crimes committed against me and my boys. How would you feel?

So where are we now and what does all this mean for you and I. First, I am going to quickly call you and leave a message with some of the tapings of our conversations so you understand I am not bluffing about my documentation. Next, I need to let you know that I still honor your intentions for coming out to me and sharing with me all the wrong that has been done to my children. Against the advice of my lawyer, I am extending to you an opportunity to once again join with me and fight these criminals that are hurting Georgia families. Whether you choose to join with me today, you must know however, that I am going forward on many different fronts with the information I have. As you are probably already aware, you are not the only person in Tusan's circle who is involved now...and if you are not aware, you will be very shortly. My hope is that you do the following. Call me within the next 24 hours. If you do not call me within the next 24 hours, I will take it as if you have made your decision regarding

your participation on team cover up or team clean up. If you chose to call me, I will give you a say in how the information about Tusan, yourself and other players is used going forward. Unfortunately, there is no in between for you going forward. You are either going to be the hero that initially prompted your call to Chirico, or the zero that had you put your head down and participate in the crimes against several fulton county residents. Krystal, I truly believe you are a hero and have it in you. If I thought for a moment that you were of the Tusan ilk, I would not extend to you this opportunity. What is in it for me? Why don't I just move forward without you? ?What does moving forward look like without you?

?What is in it for me? Having you as one of the key witnesses gives a certain gravity to this affair. Your participation can help us more accurately pose questions and form arguments and claims against the wrongdoers at least on the front end of things. The emails that you promised me would be very helpful to have before they are subpoenaed even though the FBI has confirmed to me that they cannot be erased either from the court's records or yours. In full disclosure to you, I have found out that there are approximately 1800 emails which you have in your possession and would expect everyone to be present when you produce them. Lastly, I get to work with you on helping my boys and others rather than working against you. I do not want another Tusan to have to chase down, but as you know by now, I am literally, relentless and will do whatever I have to do within the bounds of the law to get help for my children and justice for me and my crooked ex-wife. There was beauty in your reaching out to me to help my family Krystal...I want to align myself with that part of you.

?Why don't I just move forward without you? I have been advised by my lawyer to do so as he sees your recent reactions as evidence as to why you can never be trusted. He also thinks that my letting you know before hand will give you an opportunity to prepare some defensive strategy. I choose to disagree with him. I believe it is very possible but I want to give you a chance before denying you that opportunity. He wanted me to just send out the subpoenas with the written transcripts in them and give you no choice in the matter. He wanted me to not tell you about my recordings and then get you as a hostile witness when you were being examined at trial or upon deposition. He feels that with all the evidence that we already have, your perjuring yourself under oath before a jury would powerfully buttress my case and arguments. I do not want to go that route. Again, the goodness within you that had you come out in the beginning is still there and I do not want to attempt to orchestrate an environment where you are compelled to do your worst. I believe we can do more good together in this than if we are separated with opposing agendas. In fact for you, you would have 2 different sides opposing you and for that person that initially reached out, I believe that would be very unfair.

And finally,?what does moving forward without you look like? It really looks pretty much the same in most aspects. For my behavior, nothing will change. I am going to move forward on all fronts, state, federal, media, criminal, and most importantly, the FBI...with you or without you. With you beside me sharing your experiences and written communications, you will be an integral part of the clean up and immune from suit regarding your participation. With you opposing and resisting the truthful and transparent dissemination of information related to court misconduct and crime, you will be choosing to align yourself with those criminal entities and therefore a subject of same penalties and consequences. Again, I want to make you a hero...and you would be so. I want to work with you and use what was beautiful about you when you came out...but I don't need you to commence this process. I have 5.75 hours of legally audiotaped conversations, I have 2.5 hours of videotape, I have

several emails and texts over a three week period. All of this documentation is enough to go where I need to go, but you could still be a difference maker for us.

When I initially asked you during our first conversation if you would be willing to help not just me, but the other families who have been hurt. This injustice is much bigger than me and my family and you were reluctant to engage me and said, "I don't know about that, I need to be subpoenaed about your case only." I am no longer willing to curtail my motivations to help others beyond my boys. As you have so eloquently stated, Tusan is not the only judge harming families here in Fulton County. All I can say to you is this... My encouragement to you is to do what is right, lawful and just. There should be no doubt in your mind that doing right by my children and me is the only right thing to do. If you attempt anything other than that, it will be confirmation that you have chosen an adversarial stance and once again have aligned yourself with the corruptive elements and therefore, are one in the same. It is now 143pm on a Sunday afternoon. Although I encourage you not to use it, you have until 11am tomorrow morning to contact me about this matter and set up a meeting ASAP. I will be around all day today willing to converse. If you do not reach out to me by 11am on Monday the 13<sup>th</sup> of May, I will know that you have chosen not to join with me in the clean up. Please choose what is right Krystal.
